Presidential Management Fellowship (PMF) **Finalists 1993-2006**

Having celebrated its 25th anniversary in 2002, the Presidential Management Fellowship (formerly Internship) Program is designed to attract to the Federal service outstanding individuals from a wide variety of academic disciplines who have an interest in, and commitment to, a career in the analysis and management of public policies and programs. PMFs receive an initial two-year appointment at the GS-9 level, move to a GS-11 by their second year, and may be eligible for conversion to a permanent position and further promotional opportunities by the end of their assignment.

PMF postings take place in all cabinet departments and more than 50 Federal agencies. A strong emphasis is placed on career development during the two-year program; including seminars, briefings, conferences, and other on-the-job training opportunities. PMFs may also rotate to other agencies and departments to gain additional government policy exposure. The Monterey Institute of International Studies continues to be one of the top schools in the country for PMF placement.
